



1. TERMS OF RENTAL AGREEMENT & EQUIPMENT HIRE

As signed, The lessee hires from Jumping Jumpers as Lessor, one unit: (Jumping Castle).

Deposit is required at time of booking and is only refundable in extreme weather conditions such as high wind or hail. We reserve the right to cancel any booking at any time.

2. DELIVERY

The lessee, grant the Lessor the right to enter property specified above, for the delivery and pick up of the unit hired at the specified time. And by their instructions we bring our equipment into their property.

3. TRANSPORTATION AND SUPERVISION

All Charges in delivering and subsequent pick up of the unit hired to specified address are included in the Rental fee. Which is to be paid at time of delivery of the castle. The person hiring the equipment from Jumping Jumpers, must provide adequate supervision whilst children are playing in the inflatable, unless you have hired a supervisor from us. By not hiring a supervisor directly from Jumping Jumpers, you hereby release Jumping Jumpers from any insurance or legal claim due to injury caused by no adequate supervision.

TRANSPORTATION EXPENSE: Except as provided herein, all charges in delivering and subsequent pick up of the unit with respect to the Delivery Address are included in the Rental Fee noted above. In the event that the unit is not returned at the appointed time by Lessee to Lessor then \$50.00 Transportation Fee shall be automatically imposed.

4. GENERAL RULES TO FOLLOW DURING USE OF UNIT

- (A) Only compatible groups and sizes of people shall play on the unit at one time.
- (B) All participants MUST REMOVE SHOES before entering unit.
- (C) To avoid all injuries to back and neck, FLIPS ARE NOT ALLOWED.
- (D) YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED AT ALL TIMES.
CHILDRENS SAFETY DEPENDS ON YOU. AS THE LESSEE OF THE BOUNCY CASTLES UNIT, THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY.
- (E) Absolutely 'NO SILLY STRING, GUM, CANDY, FOOD, FACE PAINT AND DRINK' or any other sticky substances are allowed in the unit. If such items or traces of are found inside the Castle then a cleaning charge of \$50 will be required to be paid.
- (F) DO NOT MOVE the Jumping Jumpers Jumping Castle Unit from the place where it was installed. If the unit moves pull the corner back to the place of original installation.
KEEP THE UNIT AWAY FROM SWIMMING POOLS AND BON FIRES.

IMPORTANT INSTRUCTIONS

ALL UNITS AND EQUIPMENT ARE VERY RELIABLE. Should the unit in any case start to deflate, the motor may have stopped. In this case check the connection at the outlet near the motor, to ensure connection is snug. If necessary re connect. In the event of a power failure, EVACUATE THE UNIT IMMEDIATELY. **If problem cannot be corrected, contact us on 0405430155 (Elie) or 0412980137 (Chantal)**

6. SAFETY OPERATION ACKNOWLEDGMENT

Lessee represents and warrants the safe return of the unit and hereby agrees to pay the full price on the hired items, if not returned or damaged. The lessee acknowledges that he/she has been instructed about and fully understands the safe operations of the unit that is subject of this rental agreement.

7. MAINTENANCE

Lessee agrees to keep the unit in the same condition as when received, ordinary wear is expected. The Lessee will pay for any castles that exceed general cleaning standards. No bonfires, candy, soft drinks, chocolate, face paints or fireworks near the unit. Customer will pay for ash and fire damage and cleaning.

8. ALTERATIONS AND ATTACHMENTS

No alterations will be made to the unit without prior written approval of Lessor. 9.

WARRANTY

Lessor warrants that the unit leased under this Rental Agreement will be in good working condition on the order on the effective dates of the Rental Agreement. The unit is supplied and maintained subject this warranty. Lessor's obligation under this Rental Agreement is limited to repair and replacement of the unit when Lessor determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranty's expressed or implied, and of any and all obligations and of all liabilities on the part of the Lessor for damages including, but not limited to, consequential damages, arising out of or in the connection with the use or performance of the unit.

10. TITLE TO

Lessee agrees to keep the Jumping Jumpers jumping castle unit in his/her custody not to sublease, rent, sell or remove from the delivery address or otherwise transfer such unit. The unit will remain the property of the Lessor and may be removed by Lessor anytime after the termination of the rental agreement.

11. RELEASE OF LIABILITY

The Lessee shall be in charge of the unit's operation and is fully responsible for its operation as well as return of the Jumping Jumpers jumping Castle or sumo suits unit in good working order. Lessor and its officers, employees and agents is/are not responsible for injury occurring to the Lessee or any other person using the unit or sumo suits, and the Lessee further agrees to hold the Lessor and it's officers, employees and agents free and harmless against any injury or claims. The Lessee shall indemnify the Lessor and it's officers, employees and agents from and against any costs incurred due to the claims from

anyone and for attorney's fees and related costs involving the use and return of the unit or the use and return of sumo suits, should legal action become necessary.

12. ENTIRE AGREEMENT

The Rental Agreement constitutes the full agreement between Lessor and Lessee. Time is of the essence in this Rental Agreement. The receipt of the unit that is subject of the rental agreement is in good working order and repair and this is so acknowledged by Lessee.

13. RAIN POLICY

During periods of service weather conditions, (ie.. rain, high winds), we reserve the right to cancel your reservations. If conditions are not too severe we will give you the option of keeping the booking or not. If you decide to keep the unit for the term of this rental agreement, there will be no refunds! If, before the delivery of the unit, you wish to cancel the Unit due to adverse weather conditions, the deposit is fully refundable. Any Injuries and damages, which may occur during this time, will be the responsibility of the Lessee. The Unit is always secured to the best of Jumping Jumpers jumping castles ability, considering weather conditions, which may arise suddenly that we were unaware of. It is the Lessee's responsibility to keep an eye on weather conditions as they change throughout the time of the hire. Switch the unit off if weather conditions change. If there is no wind but there is rain, please keep the Jumping Castle on, as when it is turned off and is flat on the ground, the water does get into the castle and makes it a mission to remove. This way we can remove the jumping castle with minimal water inside it.
